Information we collect

The personal information that you are asked to provide, and the reasons why you are asked to provide it, will be made clear to you at the point we ask you to provide your personal information.

If you contact us directly, we may receive additional information about you such as your name, email address, phone number, the contents of the message and/or attachments you may send us, and any other information you may choose to provide.

When you register for an Account, we may ask for your contact information, including items such as name, company name, address, email address, and telephone number.

How we use your information

We use the information we collect in various ways, including to:

- Provide, operate, and maintain our website
- Improve, personalize, and expand our website
- Understand and analyze how you use our website
- Develop new products, services, features, and functionality
- Communicate with you, either directly or through one of our partners, including for customer service, to provide you with updates and other information relating to the website, and for marketing and promotional purposes
- Send you emails
- Find and prevent fraud

Information Collection and Use

If you choose to use AdBud Technologies AB, then you agree to the collection and use of information in relation to this policy. The Personal Information that we collect is used for providing and improving AdBud Technologies AB. We will not use or share your information with anyone except as described in this Privacy Policy.

For a better experience, and in order to provide our Service, we may require you to provide us, either directly or indirectly, with certain personally identifiable information, including but not limited to user name, and Oauth2 credentials. The information that we request will be retained by us and used as described in this privacy policy.

What information do we collect?

When you connect your Google Analytics account to our service, we will use that to download performance data from that account and we will use it to improve your advertising in Google Ads.

How do we use the information?

We use this data to improve your advertising on Google Ads. This performance data gives us valuable insights as to how visitors behave, and how relevant your visitors are. We will also use this information to connect your Google Analytics account to the Google Ads Account to enhance the experience and simplify the analysis of your Google Analytics account.

What information do we share?

Third parties we may share personal information with include (but are not limited to):

- those who assist us in providing services, and who perform technical operations such as data storage;
- law enforcement and prosecuting authorities, including international law enforcement and examining bodies;

Log Files

AdBud follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

Cookies and Web Beacons

Like any other website, AdBud uses 'cookies'. These cookies are used to store information including visitors' preferences, and the pages on the website that the visitor accessed or visited. The information is used to optimize the users' experience by customizing our web page content based on visitors' browser type and/or other information.

Advertising Partners Privacy Policies

You may consult this list to find the Privacy Policy for each of the advertising partners of AdBud. Third-party ad servers or ad networks uses technologies like cookies, JavaScript, or Web Beacons that are used in their respective advertisements and links that appear on AdBud, which are sent directly to users' browser. They automatically receive your IP address when this occurs.
